UPON COMPLETION OF THE TWO-DAY TRAINING COURSE A WRITTEN EXAM WILL BE ADMINISTERED. AN OVERALL SCORE OF 80% IS REQUIRED FOR CERTIFICATION.

CERTIFICATION IS VALID FOR TWO-YEARS. RENEWAL REQUIRES A NOMINAL RENEWAL FEE AND 20 CONTINUING EDUCATION UNITS (CEU'S). CEU'S ARE EARNED AT THE RATE OF ONE (1) PER EACH HOUR OF APPROVED TRAINING.

THE REGISTRATION FEE OF \$150.00 INCLUDES ALL HANDOUTS, MATERIALS AND TEST FEES, AS WELL AS TWO YEARS OF CERTIFICATION WITH A SCORE OF 80% OR GREATER.
